**“MyHER Interactive June 2019” Sweepstakes**  
**Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Participation in the My Home Energy Report (MyHER) Program is not required to enter. The “MyHER Interactive June 2019” Sweepstakes (“Sweepstakes”) begins on June 6, 2019 and ends on August 15, 2019 (“Sweepstakes Period”).

**Sponsor/Administrator:** The Sweepstakes is sponsored by Duke Energy Progress, LLC, Duke Energy Indiana, LLC, Duke Energy Kentucky, Inc., Duke Energy Ohio, Inc., and Duke Energy Carolinas, LLC, P.O. Box 1006, Mail code ST24A, Charlotte, NC 28201-1006 (the “Sponsor”) and administered by American Sweepstakes & Promotion Co., Inc., 300 State St., Suite 402, Rochester, NY 14614 (the “Administrator”).

**Eligibility: Duke Energy customers in Duke Energy Progress and Duke Energy Territories:** The Sweepstakes is open to all legal U.S. residents who: (i) are active Duke Energy customers, (ii) reside in North Carolina, South Carolina, Ohio, Indiana, and Kentucky and (iii) are 18 years of age or older at the time of entry. Participation is limited to one entry per active account. Employees, officers, directors and representatives of Sponsor and Administrator, its parent company, affiliates, subsidiaries, licensees, service providers, advertising and promotion agencies, those involved in the production, development, implementation or handling of the Sweepstakes, any agents acting on behalf of the above entities, as well as the immediate family members (parents, children, siblings, spouses) and/or persons living in the same household (whether related or not) of each are not eligible to participate in the Sweepstakes. All federal, state and local laws and regulations apply. **Void where prohibited or restricted by law.**

**Two Ways to Enter:**

**1). Online** - During the Sweepstakes Period, the Sponsor will send an email blast containing an embedded link to any person who is currently eligible for the MyHER Program and for which Duke Energy has a valid email address. Eligible Entrants can enter the Sweepstakes by clicking on the link and enrolling into the MyHer Interactive Website. The Sponsor will also advertise the Sweepstakes on the Sponsor’s website (with and embedded link), as well as include the URL in mailed Home Energy Reports and an embedded link within emailed Home Energy reports. All required information must be provided to enter and to be eligible to win.

**2). Mail In** – Eligible entrants also have the option to obtain one (1) Sweepstakes entry via mail by legibly hand-printing, on a 3”x 5” card or paper, their full name, complete mailing address, phone number, and mailing the card in a sealed envelope, with proper postage affixed an mail to: “MyHER Interactive June 2019” Sweepstakes 300 State Street Suite 402, Rochester, NY 14614. All entries must be postmarked by August 15, 2019, and received by August 20, 2019. **Limit one (1) entry per person regardless of the method of entry.**

The winner will be notified confirmation will be sent to winner in writing via USPS mail, or other home delivery service of Sponsor’s choice. The winners are responsible for all applicable federal, state and local taxes and/or any other fees/costs associated with the prize or receipt of the prize. In the event of noncompliance with the Official Rules, if a potential

winner cannot be reached at the address/phone number on winner's entry or if the prize or prize notification is returned as unclaimed or undeliverable, an alternate winner will be selected.
